VIII. Details of Teaching Experience at University level

Since my appointment as Lecturer 1 in the Dept. of Medicine, Faculty of Clinical Sciences, College of Medicine, University of Ibadan in 2008, I have been teaching a large number of undergraduate medical (300, 400 and 500 Level MBBS) students who rotate through Gastrointestinal and Liver Unit for a period of 6-8 weeks at least 3-5 occasions in an academic year. I give lectures at various stages of their postings. I conduct tutorials, bed-side teachings and group discussions. I also teach them some procedures that are peculiar to my unit such as, gastrointestinal endoscopy, urea breath test, liver biopsy, peritoneal biopsy, etc. I am involved in preparing examination questions, marking of scripts as well as collation of their results, during end of postings as well as during their final MBBS examinations. I am also involved in setting and conducting of Objective Structured Clinical Examination (OSCE). I give lectures and tutorials to Bachelor of Pharmacy (Pharm. D), Master of Clinical Pharmacy (MSc Pharm) and Bachelor of Dental Surgery (BDS) students of the University of Ibadan who also rotate through my unit. I take them through clinical tutorials, bedside teachings and clinical demonstrations. I coordinate the medical postings of 400 level students from the first day of their posting to the end of their posting which involves setting and conducting of end of posting examinations.

I teach and guide resident doctors during their postgraduate medical training for the Fellowship of the West African Postgraduate Medical College of Physicians and the National Postgraduate Medical College of Nigeria. I give lectures to candidates preparing for the Primary, part I and part II Examinations of the West African Postgraduate Medical College. I assess part II dissertation proposals of candidates preparing for the Fellowship Examination of the West African College of Physicians. I submit examination questions for the Primary, Part I and Part II examinations of the same college. I also take part in the examinations of part I and part II candidates of the West African Postgraduate Medical College.

Management of referred patients from local private and state general hospitals, Medical out-patients' department and in-house patients.

(b) In progress

 When are colonic polyps more detectable, during colonoscope insertion or withdrawal? Story so far: Colonic polyps are precursors for colorectal cancer and so, polyp detection rate is one of the quality measures of an effective colonoscopy. All polyps must be removed during colonoscopy because of the risk of cancer. The objective of this study was to determine when polyps are more visible. Data collection is ongoing.

Potential: If it is established that polyps are more visible during withdrawal, then it would be advised that more time should be spent during withdrawal phase of colonoscopy

- 2. Is there any correlation between the presence of alarm symptoms in patients and clinically significant upper gastrointestinal endoscopy diagnosis? Story so far: Alarm symptoms, like weight loss, recurrent vomiting, early satiety, haematemesis, melaena and others in patients with dyspepsia are believed to connote serious underlying disease, especially malignancy. So, this study aimed to evaluate the correlation between the presence of these symptoms and clinically significant endoscopic diagnosis. Data collection is still ongoing. Potential: If this correlation is established, then it will make endoscopy to be mandatory in all the patients presenting with any of these symptoms.
- 3. Evaluation of the frequency and type of proximal lesions in patients with distal colonic tumours. Story so far: Sometimes, patients with distal (rectum, sigmoid) colonic tumours may have proximal lesions which may be overlooked if the colonoscopy is not complete. This may constitute a serious error as far as the management of such patients is concerned. The aim of this

study is to evaluate how common are these proximal lesions and their nature. Presently, data collection is ongoing.

Potential: The finding of this study will highlight the importance of complete colonoscopy in patients with distal tumours.

4. Analysis of the factors responsible for delayed endoscopy in patients with upper gastrointestinal bleeding at the University College Hospital, Ibadan Story so far: Most guidelines recommend upper gastrointestinal endoscopy for patients with symptoms of UGI bleeding to be carried out with 24 hours of presentation for optimal management. However, in our setting this is not possible in most of our patients. This study therefore aim to identify some of these factors that prevent this category of patients from having early endoscopy done. Data collection is in progress.

Potential: The outcome of this study will highlight the factors responsible for delay in performing early endoscopy in such patients and possibly proffer solutions.

5. Pattern of appearance of appendiceal orifice during colonoscopy at a tertiary health facility in southwest Nigeria.

Story so far: Appendiceal orifice is one of the landmarks to identify caecal intubation during colonoscopy. However, the appearance of the orifice varies from one patient to the other and may even cause confusion for some endoscopists, who may mistake some appearances of the appendiceal orifice as an abnormality. So, the aim of this study is to describe the common normal appearances of the appendiceal orifice in our setting.

Potential: The knowledge of various normal appearances of the appendiceal orifice during colonoscopy will prevent misdiagnosis with attendant mistreatment.

6. Correlation between endoscopic and histologic Barrett's oesophagus. Story so far: Barrett's oesophagus is one of the complications of GERD and is a premalignant condition for oesophageal cancer and so, proper diagnosis is of utmost importance so as to prevent the development of oesophageal cancer. Although, histology is necessary for confirmation of this diagnosis, but sometimes Barrett's seen at endoscopy may not be confirmed histologically. So, this study aimed to evaluate the frequency of such disparity. Data collection is about to start.

Potential: The outcome of this study may prove if Barrett's oesophagus is being over-diagnosed at endoscopy.

7. Evaluation of the usefulness of hepatitis B virus genotypes and the risk of hepatocellular carcinoma.

Story so far: HBV infection is the major aetiology for HCC in our setting. There are six major genotypes of this virus and some of the genotypes have been described as aggressive. Specifically, genotypes C and D have been shown to run an aggressive course and are associated with early development of HCC. So, the aim of this study is to describe the genotype(s) most prevalent in patients with HCC. Patients recruitment and data collection are ongoing. Potential: If it is established that, the aggressive genotype(s) is (are) found in the patients with HCC, then determination of HBV genotype will be suggested as one of the mandatory tests for patients with HBV infection. So, regular monitoring and probably treatment will be suggested for patients with HBV infection found to have any of these genotypes. This is to prevent HCC.

8. Evaluation of the safety and diagnostic utility of percutaneous liver biopsy in patients with liver diseases at the University College Hospital, Ibadan

Story so far: Liver biopsy is one of the invasive procedures commonly used in hepatology for histological diagnosis of some liver diseases. However, many gastroenterologists are shying away from it due to its invasiveness. The aim of this study is to describe the diagnostic efficacy and correlation with clinical diagnosis, as well as its safety. Patients recruitment and data collection are ongoing.

Potential: The result of this study will prove the safety of this procedure, as well as correlate clinical diagnosis with histological diagnosis at our setting.

Research Focus

My research work cuts across the areas of gastrointestinal endoscopy, gastrointestinal and liver diseases. To this end, I have demonstrated the diagnostic and therapeutic efficacy of gastrointestinal endoscopy. I have studied various factors that affect efficiency of this procedure and enhance competence. I have and also in collaboration with my colleagues studied factors that enhance the safety of gastrointestinal endoscopy. I have studied patients' parameters that could determine quality measures of colonoscopy. In the area of liver diseases, I and in conjunction with other collaborators have studied the pathology of viral hepatitis B and C in asymptomatic subjects and in patients with chronic liver diseases, have described novel approaches to the diagnosis of hepatocellular carcinoma which is a major sequela of hepatitis B and C viruses on the liver. I and other collaborators have also studied the pathology and novel diagnostic approaches of *Helicobacter pylori* infection and its effects on the gut, especially in patients with dyspepsia. I was involved in a collaborative research on various aspects of *H. pylori* infection and gastro-duodenal diseases sponsored by the MacArthur Foundation of the University of Ibadan. The papers which emanated from my research activities are listed in my publications.
