I graduated with MBBS degree from College of Medicine, University of Ibadan, Ibadan Nigeria in June, 1980. I had Distinction in Pathology and Pfizer Prize for the best student in Paediatrics.

I had my housemanship in University College Hospital Ibadan from July 1, 1980 to June 30, 1981, and my National Youth Service in the old River State and served in Bakana in the old Degema Local Government between July, 1 and June 30, 1982.

I took up the position of a Medical Officer in a Private Hospital in Port Harcourt, Funtai Medical Centre from July 1, 1982 to December 30, 1984.

On January 1, 1985, I commenced residency training in Surgery in University College Hospital Ibadan. I rose from Senior House Officer in Surgery to Registrar position and on January 1, 1988 I was promoted to Senior Registrar in General Surgery.

I proceeded to Republic of Ireland to take the post of Registrar in Orthopaedics and Trauma in Our Lady of Lourdes Hospital, Drogheda, Co Louth in September 1990.

I was in this hospital till November, 1991 before moving to England in December 1991 to take up the post of Senior House Officer in Cumberland infirmary Carlise from February 1, 1982 to January 31, 1992. The Northern Regionals Health Authority with Headquarter in NewCastle upon Tyne offered me the post of Specialist Training in Orthopaedics and Trauma. - c. I have also shown that with attention to detail, plating of femoral shaft fracture can be as successful as it is in developed world.
- d. I have shown that soft tissue damage and interposition at fracture site are the main causes of non-union in our environment and also advocated that plating of Nonuion give the best outcome in our environment.
- e. I have also pioneered in our environment the use of iliac crest graft for reconstruction of mandibular defect and the technique of the procedure.

I have also looked into the outcome of management in children with club foot.
