## **My Research Interest**

My research has been in three broad areas- mental health promotion across all ages and settings, research on chronic diseases and Behaviour Change Communication. My early research is based on mental health promotion, and I have collaborated on mHealth studies. My PhD research developed culturally appropriate educational materials, and I carried out content validation of the developed educational materials. It also trained Primary health workers on maternal depression. I have worked on the research which investigated acceptability of mobile phone use for the management of postpartum depression among perinatal adolescents.
